7 ROAD SAFETY AT NIGHT FOR SCHOOL CHILDREN (ATTACHMENT B)

Statutory Basis: Local Government Act 1972, s. 137

Background

Following the decision of Committee in June 2015 (*minute* #CCS.019-15 refers) quotes have been obtained for various high visibility items that could be distributed to school children to promote road safety in the winter months.

The Current spend against the Crime Prevention budget is $\pounds 6,346$. A further $\pounds 17,000$ has already been committed ($\pounds 7,000$ to the Police for Police Cars, $\pounds 10,000$ to Durham Money Advice), leaving a total of $\pounds 6,654$ in the budget for allocation.
