#### 8 DRAFT BUDGET REVIEW

The Finance & General Purposes Committee considered the first draft budget at their meeting held on 1st November 2016. The Finance Committee noted that at present the draft budget needs to be reduced by around £150,000 in order for Council to present a balanced budget.

The Finance Committee has identified some savings in the overall budget which includes some reductions to budgets put forward by this Committee at the meeting held on 5th October 2016 These recommendations have reduced the draft budget by a total of £86, 662, which leaves a requirement to reduce the budget by a further £64,660

Committee is requested to **REVIEW** the proposed budget allocation in light of the first draft budget and make **RECOMMENDATIONS** to Full Council.

The largest budgets which the Committee is responsible for are:

Groundworks £90,000
Detached Youth Project £50,000
Durham Money Advice £30,000
