5 REQUEST FROM THE JUST FOR WOMEN CENTRE* (ATTACHMENT A)

At the last Ordinary Council meeting held on 24th October 2017, the Council RESOLVED that it would withdraw its bid to acquire the former Durham County Council offices in Stanley. As members will be aware, the Just for Women Centre were partners in the original bid submitted to DCC to acquire the building.

The Just for Women Centre have approached the Town Council with a proposal to secure an alternative location within Stanley to relocate their operation to, and are seeking the support of the Town Council. The matter is time-sensitive as the alternative premises are being offered on the open market and the Just for Women Centre have now been given notice to vacate their current premises by their existing landlords. The premises is being offered for sale at the present time.

Council is requested to CONSIDER this matter and DECIDE what to do.
