8 GRANTS

The applicants who requested grant funding in September 2017 have been provided with a copy of the revised Grants policy and requested to consider if they meet the criteria within the new policy and either resubmit or withdraw their applications in line with the new policy. The Town Clerk has assessed the applications for compliance with the policy and made comments below.

Due to the emergency grant made to the Citizens Advice Bureau to maintain the service in Stanley, there is only £15,569 remaining in the grants budget for 2017/18

Applications

(i) Joan Dodds - Stanley Brass Contest - £3,000

(ATTACHMENT E)

Note: The application is not from a constituted organisation. The application relates to an event which was scheduled to take place in October 2017. These are both disqualifying criteria under the policy.

(ii) Derwentside Mind - Mental Health Services - £10,000 (ATTACHMENT F)

Note: The application meets the criteria in the grants policy.

(iii) Stanley Indoor Bowls Centre - £23,000

(ATTACHMENT G)

Note: The policy states that grants will not be made to organisations which operate "chiefly for the social enjoyment of their members". The amount requested is more than is within the scope of the policy to award. The club states that it has 260 members. The club does host some large events which could have an economic benefit to the area by bringing people to the town for the event.

(iv) North East Horticultural Show - £6,000

(ATTACHMENT H)

Note: The policy states that grants will not be made to organisations which operate "chiefly for the social enjoyment of their members". The event could have an economic benefit to the area by bringing people to the town for the event.

(v) SHAID - Homelessness Support - £12,000

(ATTACHMENT I)

Note: The application meets the criteria in the policy, except that the request is for more than the £10,000 specified as the maximum single grant.

Committee is requested to **CONSIDER** the applications and **DECIDE** what to do. Please note that if the Committee wishes to award grants in excess of the budget, this will need to be deferred to Full Council for decision. Given the budget is overspent in other areas (Civic Hall) it is likely additional awards would have to be found from reserves.
