II MIF APPLICATION

(ATTACHMENT E)

The Town Mayor has received a request for funding which relates to an individual request for support which he has expressed an interest in supporting. The request is attached for information.

Under section 137 of the Local Government Act 1972;

"A local authority may ... incur expenditure which in their opinion is in the interests of, and will bring direct benefit to, their area or any part of it or all or some of its inhabitants, but a local authority shall not, by virtue of this subsection, incur any expenditure—

- (a) for a purpose for which they are, either unconditionally or subject to any limitation or to the satisfaction of any condition, authorised or required to make any payment by or by virtue of any other enactment; nor
- (b) unless the direct benefit accruing to their area or any part of it or to all or some of the inhabitants of their area will be commensurate with the expenditure to be incurred."

The legislation does not preclude funding individuals; however because these circumstances fall outside the Council's policy, the decision in this instance requires the opinion of Council to determine if the request "will bring direct benefit to their area"

13 HERITAGE PLAQUE SUBMISSION

(ATTACHMENT H)

The Town Clerk has received a nomination for a heritage plaque from Tanfield Railway. The nomination relates to Matthew Kirtley, (1813-1873) who was from Clough Dene and was amongst the pioneers of the railways in England, eventually becoming the Chief Mechanical Engineer for the Midland Railway, one of the major pre-grouping railway companies.

The Derby Locomotive works was built under his supervision and was a major locomotive manufacture and repair centre until its closure in 1990. His steam locomotive designs survived in service until the end of steam on British Railways and some were sold overseas

and continued in use even longer. Locomotives designed by Kirtley were taken to France in World War I and used to support the war effort.

Biographical and other information provided by the nominee is attached for the information of members.

Council is requested to CONSIDER this matter and DECIDE what to do.

NOTE: Matthew Kirtley meets all the criteria be recognised under the heritage plaque scheme. The house he lived in has been demolished and the site is now a private back garden, however a suitable location in the vicinity could be found to display the plaque.
