5 CHRISTMAS LIGHTS

The Council's previous three year contract for the provision of Christmas lights finished after the 2017 festive season. The working group established to review the provision of lights took the decision to approach festive lighting differently, focusing on the illumination of real trees, using the trees the Council has illuminated outside the Civic Hall as a model.

A report was presented to the Finance & General Purposes Committee in September highlighting a number of locations around the Parish for the provision of lights. The Committee also **RECOMMENDED** that finance be committed from reserves to provide the lights which could be returned over a number of years through revenue budgets.

The Committee directed officers to investigate costs and report back to Council for decision.

The report from the Finance and General Purposes Committee is provided as ATTACHMENT A.

A further report providing details of costs and suitability of locations is attached as **ATTACHMENT B.**

Council is requested to CONSIDER this matter and DECIDE what to do.

RECOMMENDATION: The Council should authorise the additional revenue requested to enable the Town Centre installation to be taken forward for 2018 and the additional sites should have the necessary infrastructure works put in place immediately following Christmas to illuminate the remaining locations.
