## 5 HONORARY FREEMAN OF STANLEY

Local Government Act 1972, s. 249(5)

The Local Government Act provides that:

"A relevant authority may admit to be honorary freemen or honorary freewomen of the place or area for which it is the authority—

- (a) persons of distinction, and
- (b) persons who have, in the opinion of the authority, rendered eminent services to that place or area."

In order to exercise the above power, the Council must:

- (i) make a resolution at a meeting which is specially convened for the purpose (and where notice of the object of the meeting has been given); and
- (ii) the resolution must be made by a majority of not less than two-thirds of the members who vote on it.

Cllr Les Timbey has tabled the following motion for consideration by the Council:

"On the night of 3rd June 1989, boxer Glenn McCrory, from Annfield Plain, defeated Patrick Lumumba of Kenya at the Louisa Centre in Stanley to win the Cruiserweight IBF World Championship.

This is almost certainly the most outstanding sporting achievement by any person from the Stanley area in history, and even more remarkable is that the fight was staged here in Stanley, at the Louisa Centre.

I feel that Glenn McCrory is a person of distinction whose remarkable personal achievement deserves the recognition of his peers and his community.

I therefore MOVE that Glenn McCrory is admitted to be an honorary freeman of Stanley"

Council is requested to CONSIDER this matter and DECIDE what to do.

In accordance with the Public Bodies (Admission to Meetings) Act 1960, members of the public and press are welcome to attend the meeting. Members of the public will only be permitted to speak at the beginning of the meeting during Public Question Time.
